
Opec meets on output hike as oil prices rally

REUTERS London, October 3

OPEC AND ITS allies meet on Monday to debate how much oil to release into the red hot market, where supply disruptions and recovering demand from the coronavirus pandemic have pushed oil above \$80 per barrel.

The oil price rally to a three-year high is exacerbated by an even bigger increase in gas prices, which have spiked 300% and have come to trade close to an equivalent of \$200 per barrel due to supply shortages and low production of other fuels.

The Organization of the Petroleum Exporting Countries and allies led by Russia, known as Opec+, agreed in July to boost output by 400,000 barrels per day every month until at least April



2022 to phase out 5.8 million bpd of existing cuts.

Four Opec+ sources told Reuters last week producers were considering adding more than that deal envisaged, but none gave details on how much more, or when supply would increase.

The nearest month any increase could occur is Novem ber since Opec+'s last meeting decided the October volumes.

Rising oil, gas, coal and power prices are feeding inflationary pressures worldwide and slowing the recovery.

कोरोना के 33 नए मामले

जनसत्ता संवाददाता नई दिल्ली, 3 अक्तूबर।

स्वास्थ्य विभाग की ओर से दी गई जानकारी के मुताबिक दिल्ली में रविवार को लगातार दूसरे दिन कोरोना के 33 नए मामले दर्ज हुए। इस दौरान संक्रमण दर में बढ़ोतरी हुई मगर राहत की बात यह रही कि संक्रमण से किसी की मौत नहीं हुई है। रविवार को संक्रमण दर 0.07 फीसद हो गई जबिक शनिवार को संक्रमण दर 0.05 फीसद दर्ज की

दिल्ली में संक्रमण से अबतक 25,088 मरीजों की मौत हुई है। स्वास्थ्य बुलेटिन के मुताबिक नए मामलों के साथ संक्रमितों की संख्या 14,38,966 हो गई है जिनमें से 14.13 लाख से ज्यादा मरीज संक्रमण से ठीक हो चुके हैं। बीते दिन 43,365 नमूनों की जांच आरटीपीसीआर पद्धति से और करीब सात हजार से ज्यादा नमूनों की जांच एंटीजन विधि से की गई।

शौचालय के इस्तेमाल को लेकर विवाद

दिल्ली को पहली बार मिलेगा प्रदूषण से लड़ने के लिए धन

नई दिल्ली, 3 अक्तूबर (भाषा)।

राष्ट्रीय राजधानी को वायु प्रदूषण प्रबंधन में महत्त्वपूर्ण किमयों को दूर करने के लिए इस साल राष्ट्रीय स्वच्छ वायु कार्यक्रम (एनसीएपी) के तहत 18 करोड़ रुपए से अधिक की राशि मिलेगी। अधिकारियों ने यह जानकारी दी। यह पहली बार है जब दिल्ली को एनसीएपी के तहत कोष दिया जाएगा। एनसीएपी, 2024 तक पीएम 2.5 और पीएम 10 की सांद्रता में 20 प्रतिशत से 30 प्रतिशत की कमी लाने के उद्देश्य से एक राष्ट्रीय स्तर की रणनीति है जिसके लिए आधार वर्ष 2017 रखा गया है।

बातचीत में एक अधिकारी ने बताया. 'दिल्ली को एनसीएपी के तहत 18.74 करोड़ रुपए मिलेंगे। 2019 में शुरू होने के बाद से यह पहली बार है जब इस कार्यक्रम के तहत दिल्ली को धन प्राप्त होगा।' एनसीएपी उन 132 शहरों को घेरता है, जो निर्धारित राष्ट्रीय परिवेश वायु गुणवत्ता मानकों (एनएएक्युएस) को पुरा नहीं करते हैं।

इन शहरों की पहचान राष्ट्रीय वायु निगरानी कार्यक्रम के तहत 2011-2015 की अवधि के दौरान प्राप्त परिवेशी वायु गुणवत्ता के आंकड़ों के आधार पर की गई है। पीएम 10 और पीएम 2.5 के लिए स्वीकार्य वार्षिक मानक क्रमशः 60 माइक्रोग्राम प्रति घन मीटर और 40 माइक्रोग्राम प्रति घन मीटर है। केंद्रीय



पर्यावरण मंत्रालय के एक अधिकारी ने बताया, 'राष्ट्रीय राजधानी को दो साल के लिए एनसीएपी के तहत कोई धन नहीं मिला क्योंकि उसके पास अन्य संसाधन के रूप में 2000 सीसी से ऊपर के डीजल वाहनों पर लगाया जाने वाला हरित उपकर, जिसे केंद्रीय प्रदुषण नियंत्रण बोर्ड (सीपीसीबी) के पास जमा किया जाता है और दिल्ली में प्रवेश करने वाले वाणिज्यिक वाहन पर लगने वाला प्रदूषण कर, उपलब्ध थे।'

इस बार एनसीएपी के तहत कोष की उपलब्धता में सुधार हुआ है। अधिकारी ने बताया, 'वित्त आयोग से 50 शहरों को पहले से ही प्रदुषण प्रबंधन के लिए अच्छी रकम

मिल रही है। इसलिए एनसीएपी के तहत शेष 82 शहरों के लिए धन की उपलब्धता में सुधार हुआ है। इसलिए हमने दिल्ली को भी कुछ कोष देने का फैसला किया है।' इन 82 शहरों के लिए इस साल कुल 290 करोड़ रुपए उपलब्ध हैं।

अधिकारी ने बताया कि जहां कहीं भी अन्य संसाधनों से उपलब्ध धन अपर्याप्त होगा, इन्हीं महत्त्वपूर्ण किमयों को पुरा करने के लिए एनसीएपी के कोष का उपयोग किया जाएगा। शेष धनराशि योजनाओं की प्रगति के माध्यम से जुटाई जानी है। निर्माण और तोड़फोड़ से निकले कचरे के प्रबंधन जैसी बड़ी परियोजनाओं के लिए स्वच्छ भारत शहरी कार्यक्रम और केंद्र सरकार की अन्य योजनाओं के तहत धन आवंटित किया जाता है।

दिल्ली सरकार ने राजधानी में वाय् प्रदूषण से निपटने के लिए 'शीतकालीन कार्य योजना' तैयार की है और मुख्यमंत्री अरविंद केजरीवाल द्वारा जल्द ही इसकी घोषणा करने की उम्मीद है।

यह योजना 10 प्रमुख मुद्दों पर केंद्रित है, जिसमें पराली जलाना, प्रदूषण हाटस्पाट, स्माग टावर का काम करना और वाहनों और धूल का प्रदुषण शामिल हैं। दिल्ली सरकार ने पहले ही एक जनवरी, 2022 तक पटाखों की बिक्री और उन्हें जलाए जाने पर पूर्ण प्रतिबंध लगा दिया है और धूल प्रदूषण को नियंत्रित करने के लिए विस्तृत दिशानिर्देश जारी किए हैं।

दिल्ली सरकार ने अदालत को बताया

दक्षिण दिल्ली में अवैध मंदिर को तोड़ने की योजना

जनसत्ता संवाददाता नई दिल्ली, ३ अक्तूबर।

दिल्ली सरकार ने दिल्ली की एक अदालत को सूचित किया है कि अधिकारी दक्षिणी दिल्ली के डिफेंस कालोनी में अवैध रूप से निर्मित मंदिर को गिराने की योजना बना रहे हैं। दिल्ली सरकार ने यह दलील तब दी जब एक संपत्ति के सामने से अतिक्रमण हटाने की मांग करने वाली एक याचिका अदालत में सुनवाई के लिए आई। न्यायमूर्ति रेखा पल्ली ने संपत्ति के मालिक की ओर से दायर याचिका पर नोटिस जारी किया और दिल्ली सरकार, पुलिस उपायुक्त (दक्षिण), हौज खास से जवाब तलब किया।

अदालत ने अधिकारियों से एक स्थिति रिपोर्ट दाखिल करने को कहते ्रहुए मामले की सुनवाई आठ अक्तूबर के लिए तय की है। दिल्ली सरकार और डीसीपी (दक्षिण) का पक्ष रख रहे वकील अनुपम श्रीवास्तव ने दलील दी कि अधिकारी अपने कर्तव्य के प्रति सचेत हैं और पहले ही स्थल पर अवैध अतिक्रमण को ध्वस्त करने की योजना बना चुके हैं।

दिल्ली मेट्रो रेल निगम (डीएमआरसी) के अधिकारियों ने बताया कि इतिहास में पहली बार चौथे चरण के कार्य के तहत मजलिस पार्क-मौजपुर गलियारे पर एक एकीकृत फ्लाईओवर और भूमिगत पारपथ (अंडरपास) का निर्माण किया जा रहा है। उन्होंने बताया कि उत्तर-पूर्वी दिल्ली के सूरघाट के पास यह परियोजना शहर के लोकनिर्माण विभाग की सहायता से क्रियान्वित की जा रही है। दिल्ली मेटो के कार्यकारी निदेशक (कारपोरेट संचार) अनुज दयाल ने एक जारी बयान में बताया कि यह पहला एकीकृत 'फ्लाईओवर कम मेट्रो वायाडक्ट स्ट्रक्चर ' होगा।

बयान में कहा गया कि लोकनिर्माण विभाग का यह फ्लाईओवरऔर वाहन अंडरपास.यमना नदी के पास प्रस्तावित



'एलिवेटेड' सड़क परियोजना का हिस्सा है जो कि वजीराबाद फ्लाईओवर और डीएनडी (दिल्ली नोएडा दिल्ली) फ्लाईवे के पास रिंग रोड के बीच स्थित समानांतर है।
